Contest Rules

1. To enter, take **one** photo, in the **horizontal** format looking into your garage from the exterior. Make sure the image is in a digital **jpeg** format. Email this image to contest@napoct.com. Next, include a description, 200 words or less, of what your dream garage would be. Be sure to include your **name** and your **home town**, and put **Contest** in the subject line. That's it!
2. This contest is open to any Connecticut homeowner, **18 years of age or older**. Homeowner must reside in the winning home.
3. Contestants **must agree to have photos of themselves and their garage** taken by NAPO-CT and **used publicly** by NAPO-CT, NAPO-CT members and NAPO-CT publicity agents.
4. **Entry deadline** is Saturday, **June 9**. Then **three finalists** will be chosen on Monday, **June 11, 2018** by NAPO-CT.
